

**Federal Defenders of Eastern Washington and Idaho  
Position Announcement**

**Training Director/Trial Attorney  
(Assistant Federal Public Defender)**

Federal Defenders of Eastern Washington and Idaho is now accepting applications for a **Training Director/Trial Attorney** position in **Spokane, Washington**. The primary practice areas will be before the U.S. District Court for the Eastern District of Washington, U.S. District Court for Idaho, and United States Court of Appeals for the Ninth Circuit. This organization litigates cases in four locations: Richland, Yakima, and Spokane, WA (all in the Eastern District of Washington); and Coeur d'Alene, ID (District of Idaho).

Federal Defenders of Eastern Washington and Idaho is the Community Defender Organization (*see* 18 U.S.C. § 3006A(g)(2)(B)) for the Eastern District of Washington and the Northern District of Idaho. The organization is a non-profit corporation funded by a grant from the federal government. Employees of Federal Defenders of Eastern Washington and Idaho are considered "at will" and are not government employees. The organization provides defense services in federal criminal cases and related matters appointed by the court. The organization's main office is in Spokane, Washington, with a branch office in Yakima, Washington.

**JOB DESCRIPTION:** This is an exciting new position for an experienced trial attorney and federal court practitioner. The Training Director/Trial Attorney will develop and organize training programs for the Fellowship Attorneys, the CJA mentees, the CJA panel and for the office employees. It is expected the attorney will stay abreast of changes in the law, trial techniques, and technology to create and continue a dynamic training program. The attorney will actively recruit diverse applicants, minorities, women, LGBTQ and disabled, for the one-year to two-year Fellowship Attorney positions which may include travel to law schools and job fairs. Because of these responsibilities, it is expected the Training Director/Trial Attorney will carry a lighter caseload. The attorney will be handling criminal cases from inception (be it pre-indictment, complaint, or indictment) to either trial or sentencing – or both, as well as handling appeals. The caseload is varied, but includes the following: 1) firearms offenses; 2) drug offenses; 3) immigration offenses; 4) child pornography and 5) white collar offenses. The Spokane office covers numerous Indian Reservations where there are many cases involving serious assaults (physical and sexual) and murders occurring in Indian Country. Regular day trips and some overnight travel is required for case investigations, court appearances, and visiting clients housed in various correctional facilities throughout Eastern Washington and Central/North Idaho. A trial attorney may not engage in the private practice of law. The attorney must be on board or provide a firm commitment by September 28, 2017.

**REQUIREMENTS & QUALIFICATIONS:** Applicants must possess the following license qualifications: 1) be a graduate of an accredited law school; 2) be admitted to practice before the highest court in a state (a Washington bar license is not required); 3) be eligible for admission to the U.S. District Court for the Eastern District of Washington and U.S. District Court of Idaho; and 4) be eligible for admission to the Ninth Circuit Court of Appeals. Regarding experience, applicants must possess at least 10 years of professional experience as a trial attorney, federal criminal practice preferred. The attorney must have tried at least five (5) felony jury trials.

**SALARY/BENEFITS:** This is a full-time position. Salary is commensurate with qualifications and experience. Salary is on a scale equivalent to that of Assistant U.S. Attorneys. Benefits are provided, and salary is payable by direct deposit.
