**YEAR AND A DAY APPOINTMENT - CLEVELAND, OHIO**

The Office of the Federal Public Defender for the Northern District of Ohio announces an immediate opening for a Research & Writing Attorney to be situated in our Cleveland, Ohio office. In accordance with the Criminal Justice Act, the FPD provides representation to individuals in federal criminal cases who are financially unable to retain counsel. The position entails representation of indigent defendants before the United States Court of Appeals for the Sixth Circuit, including oral arguments, and assistance to the FPD's trial lawyers in litigation before the District Court.

This is a full-time temporary position from which future positions may be filled.

Interested persons must have graduated from an accredited law school, be a member in good standing of any state bar, and be willing to obtain admission to practice before the United States District Court for the Northern District of Ohio and the United States Court of Appeals for the Sixth Circuit upon being hired. A minimum of three years of practice is required. Criminal trial and appellate experience is desirable, as is litigation experience in federal court. Significant work in General Courts-Martial level offenses before military trial courts, or briefing and argument before military appellate courts, is an acceptable substitute. The position requires excellent research, writing and oral advocacy skills, proficiency in computer-assisted legal research and Microsoft Word, and the ability to understand and manage complex factual and legal issues. Knowledge of and experience in the operation of post-conviction proceedings in criminal cases, including non-capital habeas corpus petitions and similar post-conviction motions are desirable. Above all, candidates must have a strong commitment to providing first-rate representation to indigent persons in proceedings under criminal law.

Employees are considered at-will and not covered by the Civil Service Reform Act. Salary is commensurate with qualifications and experience with applicable pay grades from 9 - 15 under the Judiciary Salary Plan and is subject to direct deposit. Employment is provisional pending the successful completion of a required background check.

Some travel via personal vehicle is required. This position precludes the private practice of law.
